SUMMARY ANNUAL REPORT

This is the summary annual report for the Northwest Insulation Workers Welfare Trust (the "Plan"), employer identification number 91-6035786, plan number 501, for the period July 1, 2016 to June 30, 2017. The annual report has been filed with the Employee Benefits Security Administration, as required under Employee Retirement Income Security Act of 1974 (ERISA).

INSURANCE INFORMATION

The plan had contracts with various insurance companies to pay certain medical, disability, and death claims incurred under the terms of the plan. The plan also maintains stop loss coverage for medical claims paid directly from plan assets. Total premiums paid during the plan year were \$839,495.

BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the plan, was \$15,376,225 as of June 30, 2017, compared to \$13,441,876 as of July 1, 2016. During the year the plan experienced an increase in its net assets of \$1,934,349. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$8,706,224 including employer contributions of \$7,973,140, employee contributions of \$439,962, earnings from investments of \$305,412, realized losses of \$(52,118) from the sale of investments, and other income of \$39,828. Plan expenses were \$6,771,875. These expenses included \$535,607 in administrative and operating expenses and \$6,236,268 in benefits paid to or for participants and beneficiaries.
